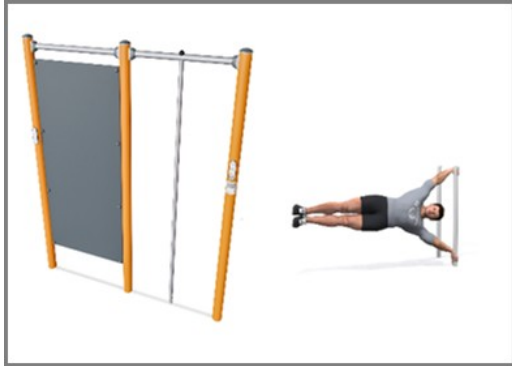

The strength of the bar is secured through a conical design and a

full steal bar. The 138cm wide pull up bars are designed to give plenty of space to dynamic exercises and promote sideways exercises such as the typewriter pull up. The wide bars also allow for users to do pull ups next to each other and thereby compete or motivate each other.

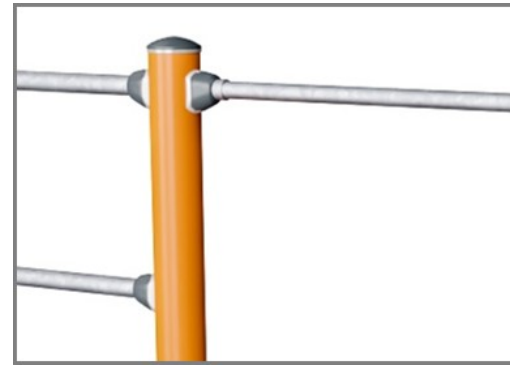

The vertical pole is made of a  $\varnothing 38 \times 2\text{mm}$  hot-dip galvanised tube, which is the perfect size for a good grip when trying to do the Human Flag!



Steps are made of extruded aluminium with a non-skid surface. Aluminium has high corrosion resistance and ensures the durability of the product. Steps have been mounted at heights of 34,7cm and 54,7cm; making it easy to reach the overhead activity



All bars intended for pull ups are made of solid,  $\varnothing 32\text{mm} \times 138\text{m}$ , hot-dip galvanised, S235JR steel bars. This diameter gives the right grip for all users.



The handles offer four different heights to place the hands or feet; 48cm, 76cm, 104cm and 132cm, creating the opportunity to scale the difficulty of the exercise.



The post is made of  $\varnothing 101.6 \times 2\text{mm}$ , pre-galvanised carbon steel and powder coated which is a great protection solution for all climate conditions.



The surface is made of Ekogrip™ panels, consisting of 15mm polyethylene with a 3mm top-layer of thermoplastic rubber. The Ekogrip™ panels have a non-skid effect for comfortable and safe training at all weather circumstances.

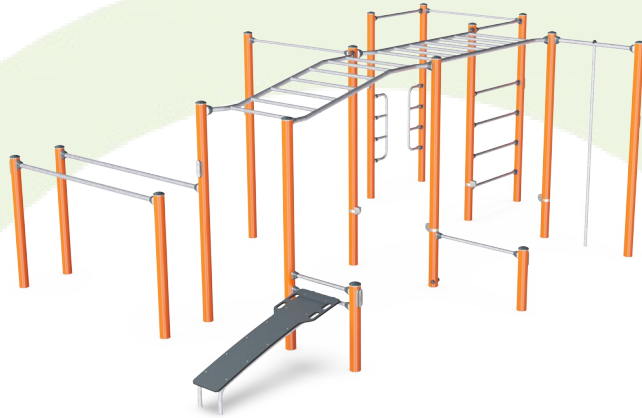

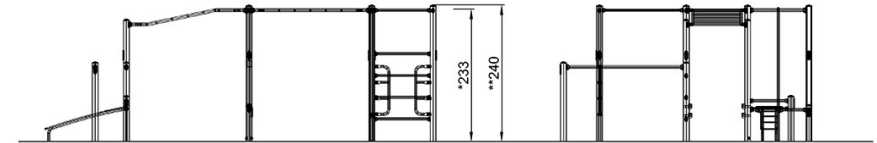
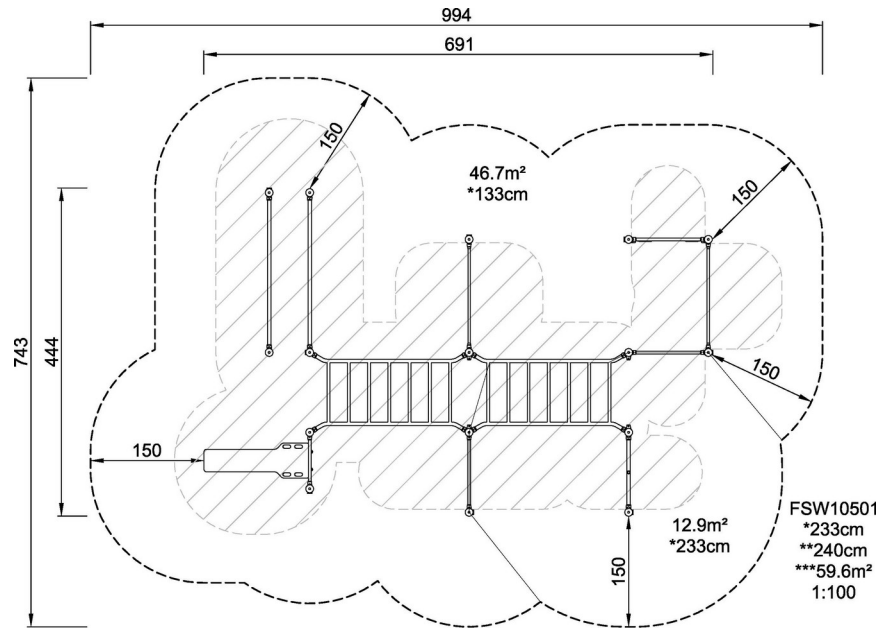
