

The main posts are made of high quality pregalvanized steel with powder coated top finish. Post tops are closed with caps of UV stabilized nylon (PA6). The grey colored molded decks are made of 75% post-consumer ocean waste PP material with a non-skid pattern and textured surface. All decks are supported by uniquely designed, low-carbon aluminum profiles with multiple attachment options.



The slides are available in either moulded PE in different colours or in full stainless steel - AISI304 t= 2mm.



The steel surfaces are hot-dip galvanised inside and outside with lead-free zinc. The galvanisation has excellent corrosion resistance in outside environments and requires low maintenance.

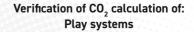





