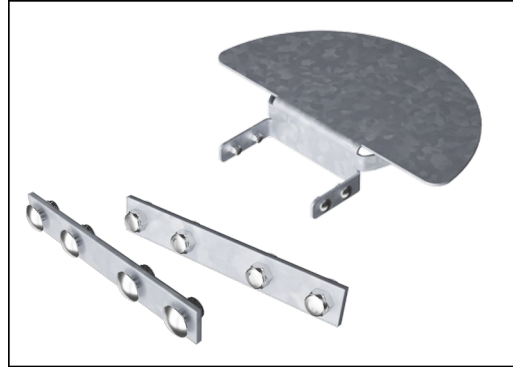

The hardware is made of stainless steel or galvanized steel to ensure durable connections with a high corrosion resistance.

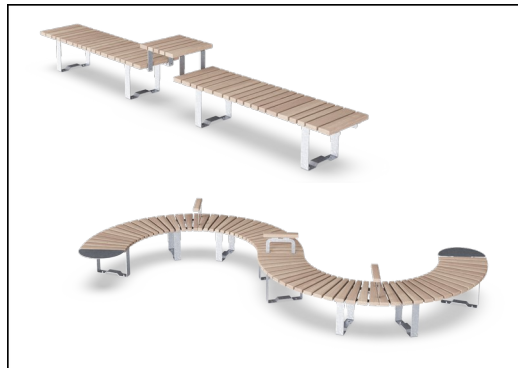

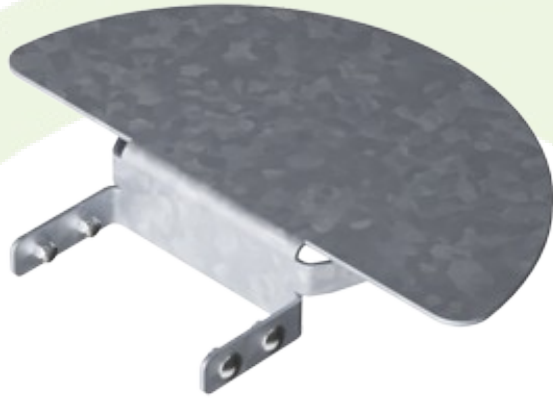
