structure that can either blend into or stand out from your surroundings. Children can touch and feel the timber while playing, observing how nature inspiration interacts with the built environment.
















### Rope handholds

The Robinia wood can be supplied as untreated raw wood or painted with a brown coloured transparent pigment that maintains the golden wood colour of the wood.







