
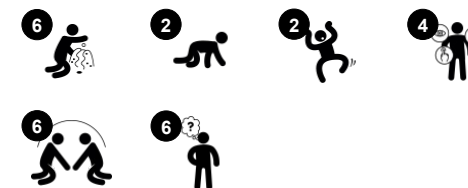

Wow! So much play in such a small space! Gleeful physical, social, and creative play is encouraged in all aspects. For toddlers, the inclination of the bridge is steep, they will hold the sides for support. This steepness train their senses of balance and space. The spatial awareness is supported by the ability to climb under and over the bridge. This supports the

understanding and incorporation of spatial relations such as over, under, higher than and lower than. These are fundamental for the understanding of e.g. mathematics later in life. The fine tactile elements respond to the child's movements and thus support the understanding of causal relations. The Billy Goat Gruff story of climbing under and over the

bridge is a strong thematic for toddlers, supporting language development. Playful learning in little space.

Panels of 19mm EcoCore™. EcoCore™ is a highly durable, eco friendly material, which is not only recyclable after use, but also consists of material produced from +95% recycled post consumer material from food packing waste.



The steel surfaces are hot dip galvanised inside and outside with lead free zinc. The galvanisation has excellent corrosion resistance in outside environments and requires low maintenance.



Steps are made of HPL with a thickness of 17,8mm with a very high wearing strength and a unique KOMPAN nonskid surface texture.

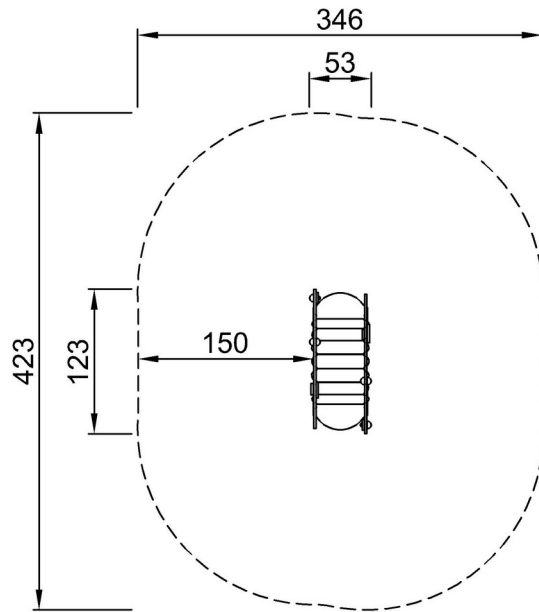
