


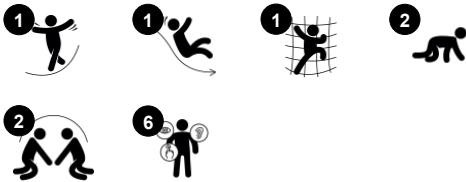

This slide play tower will inspire children to slide, climb, and come back to play actively again and again. The proportions and activities are scaled to provide optimal play stimulation for preschoolers. The pipe ladder offers a fast way up, training cross-coordination and muscles. Cross-coordination stimulates cross-modal perception, necessary for skills such as

reading. Climbing the tower is rewarded with a stomach-tickling ride down the slide, training posture, balance and core muscles when sitting upright going down. When deciding whom to go next, children develop empathy and negotiation skills. The platform provides a place to be together with friends, and the windows encourage children to communicate

with friends outside the platform.

## Slide

**Physical:** sliding develops spatial awareness and a sense of balance. Furthermore, the core muscles are trained when sitting upright going down. **Social-Emotional:** empathy stimulated by turn-taking. **Cognitive:** young children develop their understanding of space, speed and distances when sliding down quickly.



## Window

**Social-Emotional:** invites interaction between sides and cooperative play.



## Pipe ladder

**Physical:** cross coordination and eye-hand coordination are supported when children climb the ladder. The climbing also supports leg and arm muscles. **Social-Emotional:** learning about turn taking and cooperation.

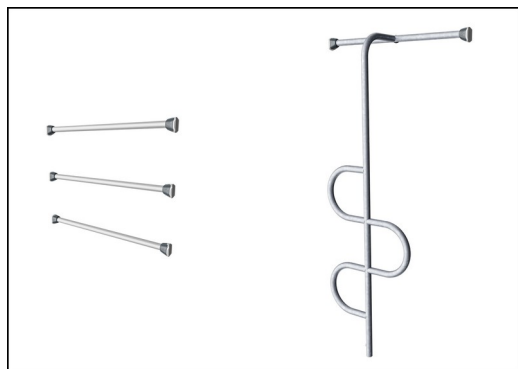

Pre-galvanized inside and outside with powder coated top finish steel posts. Lead free aluminum with color anodized top finish. Greenline TexMade posts of 95% post-consumer recycled PE and textile waste.



All decks are supported by unique designed low-carbon aluminum profiles with multiple attachment options. The grey colored molded decks are made of 75% post-consumer waste PP material with a non-skid pattern and texture surface.

Pipe ladder bars are hot dip galvanised inside and outside with lead free zinc. The galvanisation has excellent corrosion resistance in outside environments and requires low maintenance.



The slides can be chosen in six different colors and three materials: Straight or curved one-piece molded PE slides, made from 33% recycled post-consumer materials in different colours. Combined EcoCore™ sides and stainless-steel. Full stainless steel in one piece design for more vandalism proof solutions.



Wood version of FSC®-certified (FSC®C004450) pine wood with pressure impregnated base treatment and brown painted top finish. Vertical boards and top ends protected by a unique aluminum profile for high outdoor durability.

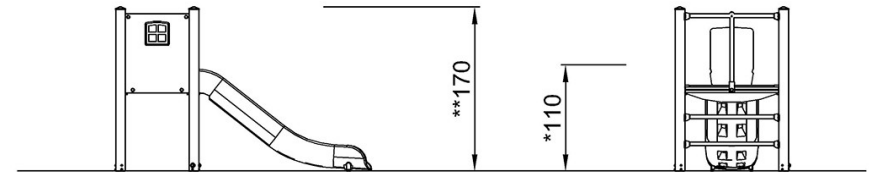
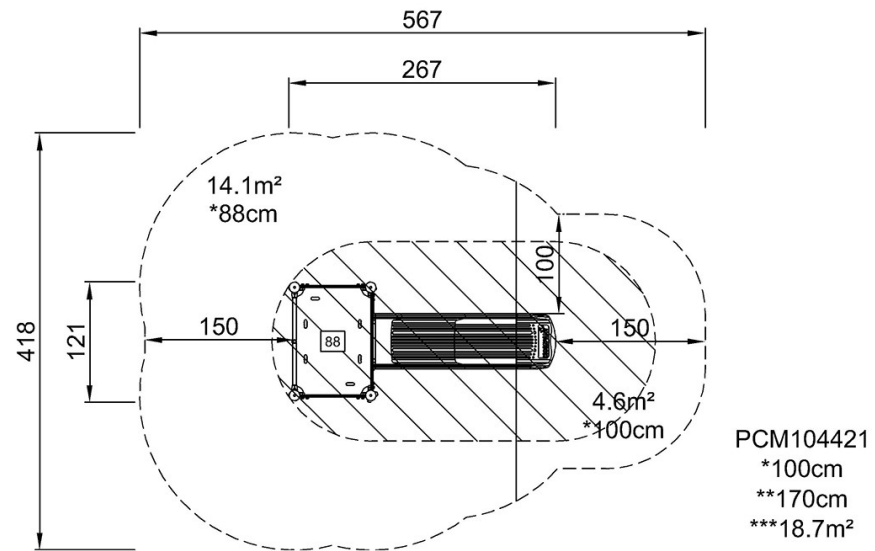
