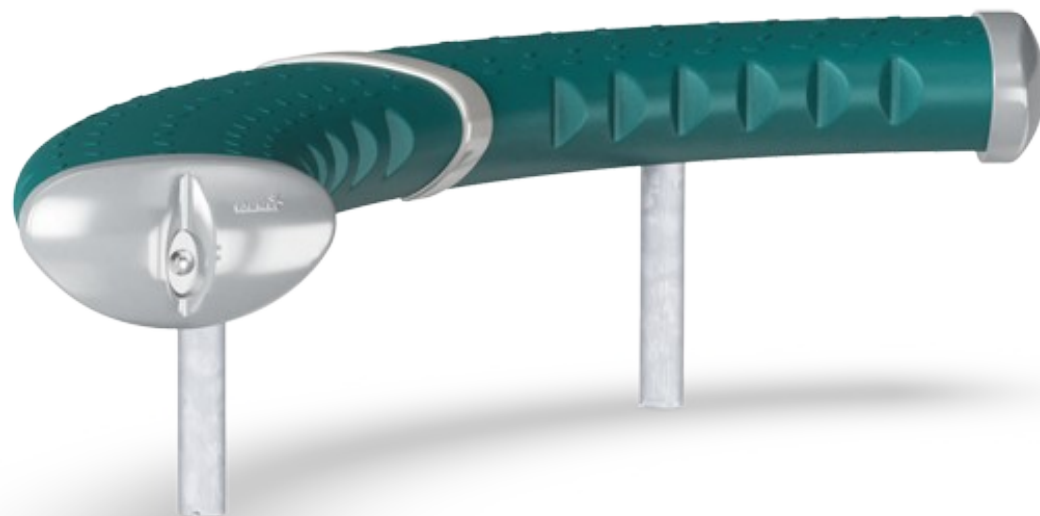

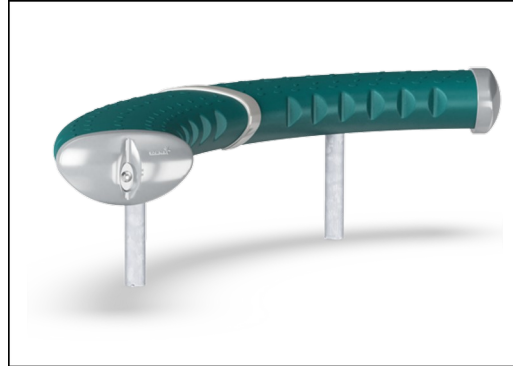
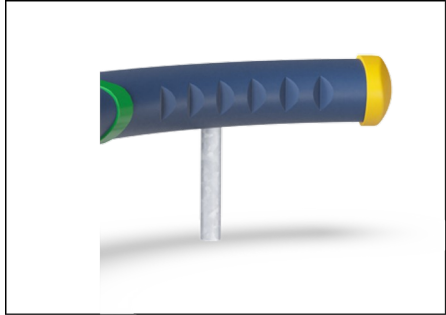


The curved benches can be installed in different heights and next to each other to create a tribune. The benches are splendid meeting points to socialise with friends and look at sport activities at the same time.
