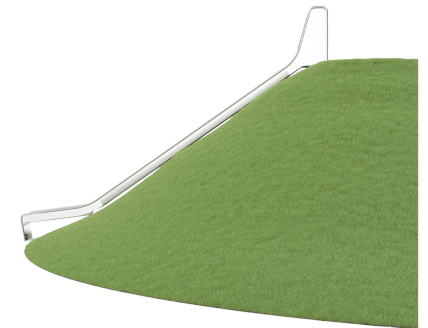

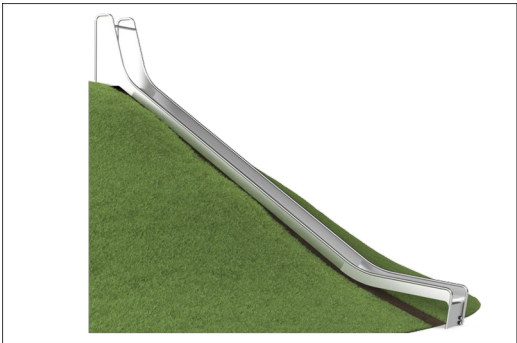

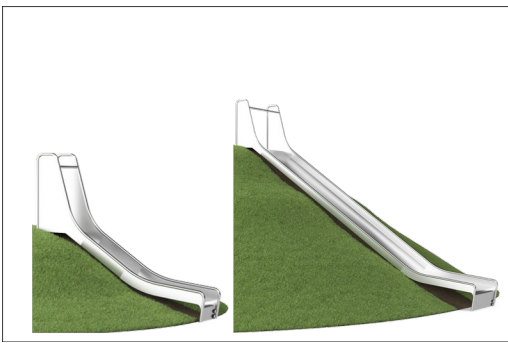

At 35°, the slide is set to the optimum angle to ensure both gliding fun and safety.



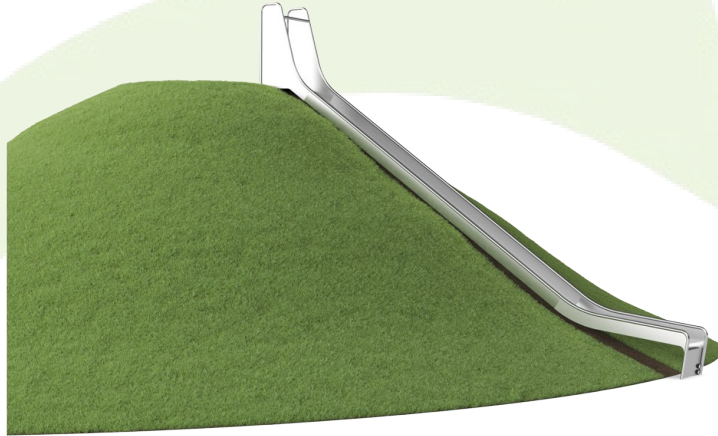
Catering to different terrains, the embankment slides are available in 9 lengths from 1 - 3m.

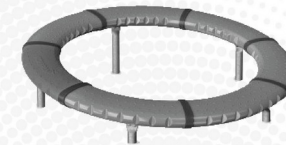

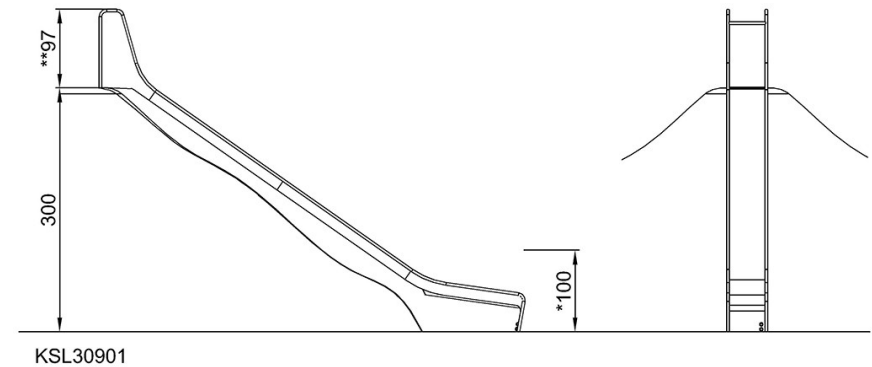
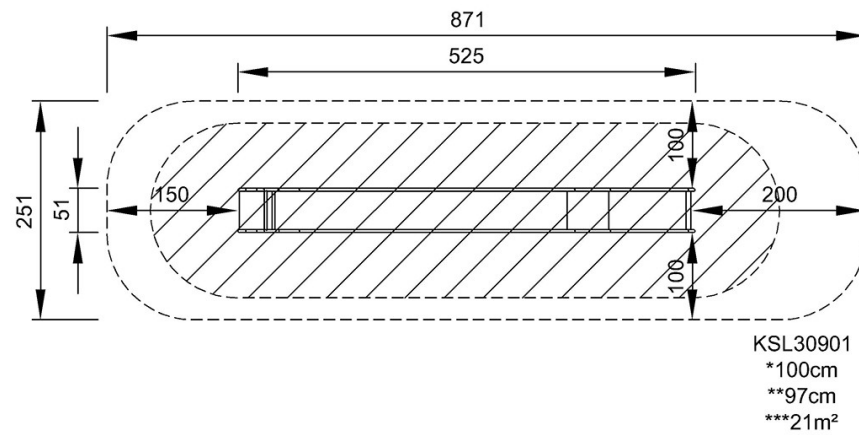
