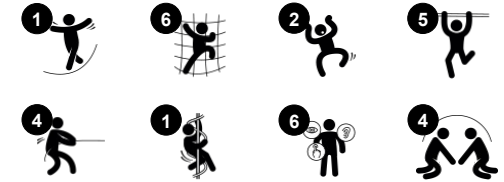

## Slide

**Physical:** sliding develops spatial awareness and a sense of balance. Furthermore, the core muscles are trained when sitting upright going down. **Social-Emotional:** empathy stimulated by turn-taking.



## Rock climber

**Physical:** supports cross coordination and leg, arm and hand strength. The hand-holds on top ease entry into platform. **Social-Emotional:** the inclination makes climbing feel secure, especially for younger children.



## Theme

**Cognitive:** suggests a theme and supports dramatic play, which stimulates language and communication skills.



## Cannon

**Cognitive:** the cannon set a tangible theme and thus spur dramatic play. Dramatic play supports language and communication skills.



## Monkey bar

**Physical:** the upper body muscles that are under-challenged due to sedentary lifestyles are developed immensely. So does the coordination and trunk stability. This type of training is preventive for backaches and cross coordination supports cooperation between the left and right brain halves, necessary for other skills such as reading.

The paint used for coloured components is water based environmentally friendly with excellent UV resistance. The paint is in compliance with EN 71 Part 3.

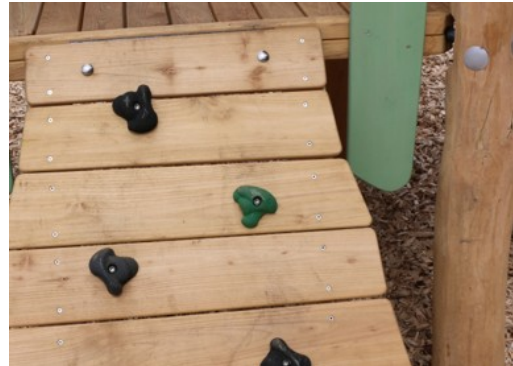

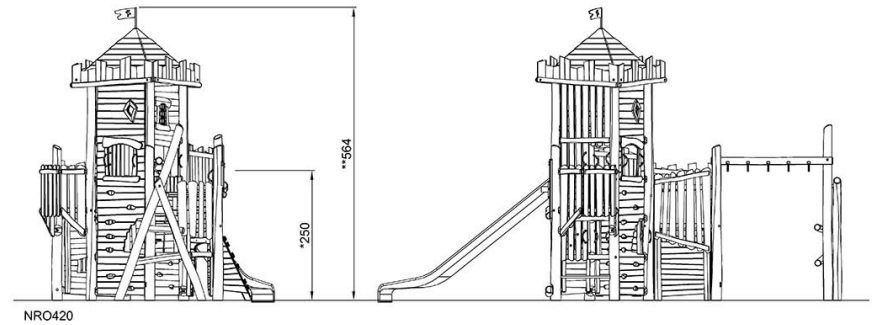
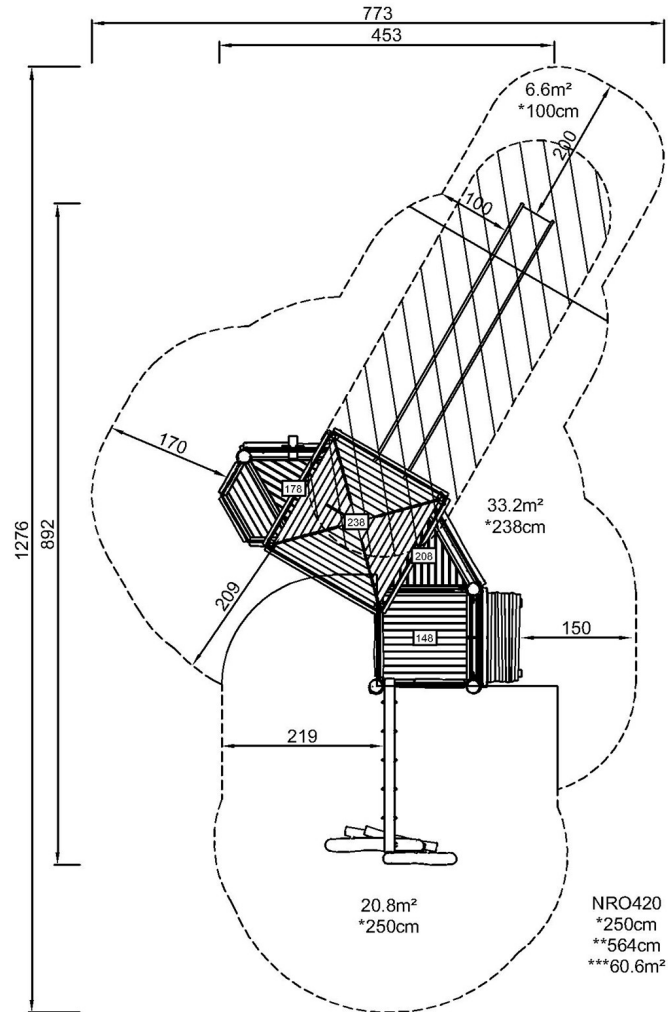
