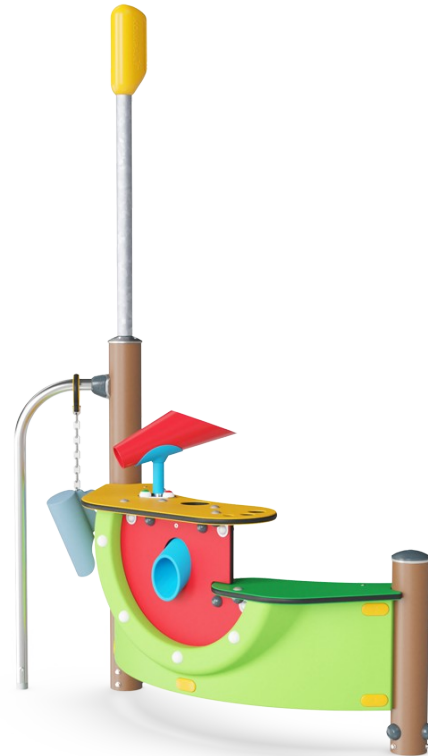

The Miner attracts children with its variety of colours. The number of sand play activities makes them come back again and again. The movable funnel can transport sand into the sieve or let it run through to the lower funnel. This stimulates the child's understanding of endurance and logical thinking. The scoop lifts sand from the ground and running it on the

tube helps build arm strength. The two table heights make cooperation possible for different ages: the youngest can use the lower table as a support for standing. Additionally, it creates a good space for working with materials. The two-sided Miner is a compact addition to any playground, providing room for children of all abilities to play together, from all sides.

Desk

Social-Emotional: fine meeting place and a space creator. Sharing and cooperation from both sides create a social scenario that supports communication and cooperation.



Sand shovel

Changeable sand funnel

Social-Emotional: supports cooperation and turn-taking as children pour water or materials into the funnel. **Cognitive:** the passing of materials through funnels develops children's logical thinking, for younger children the understanding of object permanence: that materials do not vanish, but run through. **Creative:** the sand funnel can be turned, creating new directions of dispensing materials.



The Curved ELEMENTS panels are moulded of UV stabilised recyclable PE using 33% post-consumer recycled material. With multiple options for in-build play features that also ensures a strong panel solution. Straight panels are made of KOMPAN 19mm HDPE EcoCore™ which is a highly durable, ecofriendly and recyclable material made from +95% PCM.



ELEMENTS decks are made of 17.8mm thick HPL supported by a unique designed aluminum frame with multiple attachment options by usage of aluminum connectors. The main posts are made of high quality pre-galvanised steel with powder coated top finish. Post tops are closed with caps of UV stabilised nylon (PA6).



ELEMENTS products are available in three different colour combinations: classic blue & green, blossom orange & yellow, nature lime and green.

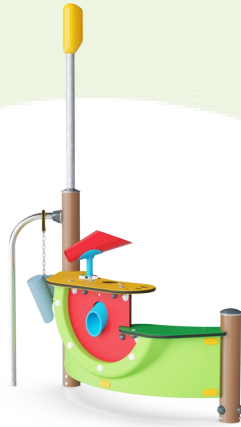

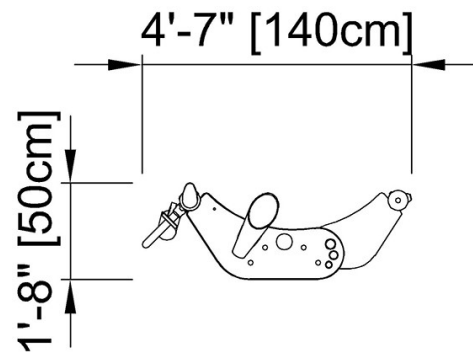

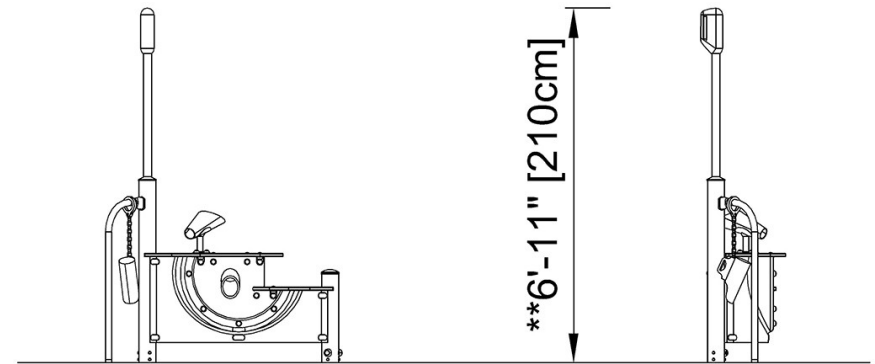
