The Mega Deck is a circle of play for all: everyone will find something to do, on either play level. This makes for a wildly appealing play unit that makes children come back for more, again and again. There is a richness of tactile activities. At ground level offers climbing, swaying and playing with the music panel. The stair or the climbing wall lead the child up,

training cross-coordination in both cases. This is an important motor skill: alternate use of left and right body half trains cooperation of the left and right side of the brain, fundamental for later reading skills. The double slide thrills and trains core muscles and balance as toddlers go down. There is room for a carer, too. For all children the curly climber adds a great rotating

sliding experience, stimulating the spatial awareness as the child winds downwards.


Hoofdstaanders met thermisch verzinkte stalen voetstukken zijn beschikbaar in verschillende materialen: Druk geïmpregneerde grenen staanders. Stalen staanders, pre-galvaniseerd van binnen en buiten en met gepoedercoate afwerking. Loodvrij aluminium met kleurgeanodiseerde afwerking. Greenline TexMade staanders van 95% post-consumer gerecycled PE en textielafval.



Alle platformen worden ondersteund door speciale, koolstofarme profielen met meerdere bevestigingsopties. De grijsgekleurde, gegoten PP platformen zijn gemaakt van 75% post-consumer materiaal en zijn voorzien van een antisliptextuur.



Wood version of FSC®-certified (FSC®C004450) pine wood with pressure impregnated base treatment and brown painted top finish. Vertical boards and top ends protected by a unique aluminum profile for high outdoor durability.



Touwen van UV-gestabiliseerde PES-touwstangen met staalraadkern. Het polyestergaren is gemaakt van +95% gerecycled post-consumer materiaal en is inductief gesmolten op iedere afzonderlijke streng.



Shade sails of commercial 95 high density PE knitted specially for sunshade structures. The sails are treated with UV stabilizers to ensure a long lifetime. The sails are supported by a hot dip galvanized steel frame. Closed sail equipped with an easy take down system.




