

slide and fireman's pole additionally build turntaking and negotiation skills. On ground level, a nice space with play table invites meetings and conversations. This is a great asset which enhances the number of players and adds the possibility to socialize and build friendships.

Counter

Physical: invites climbing, developing cross coordination. This supports cross-modal perception, which is necessary for skills such as reading. Social-Emotional: sharing and cooperation from both sides create a social scenario supporting communication and cooperation. Cognitive: the counter invites dramatic play scenarios such as playing shop. This stimulates language and communication.







Physical: sliding develops spatial awareness and a sense of balance. Furthermore, the core muscles are trained when sitting upright going down. Social-Emotional: empathy stimulated by turn-taking.



Rock climber





Physical: supports cross coordination and leg, arm and hand strength. The hand-holds on top ease entry into platform. Social-Emotional: the inclination makes climbing feel secure, especially for younger children.

Physical: coordination is supported when going down, as well as arm and core muscles. Landing strengthens bone density, which is built for life in early childhood. Social-Emotional: turn-taking and risk-taking.





