

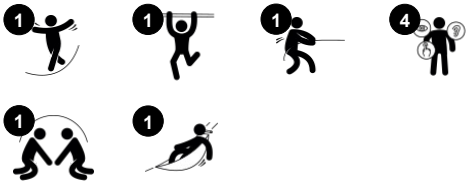

The Rope Bridge, with its classic appeal, keeps children practising tight rope walks again and again. The lower rope can be balanced on with or without the upper rope support. Learning and practising how to balance on different surfaces is fundamental for the mastery of all other motor skills. The sense of balance makes it possible for children to walk, to run – and to

avoid falling, when they trip over. Regaining balance is crucial for feeling confident in physical activity as well as when sitting still, supporting the ability to concentrate and learn. The Rope Bridge trains balance, and supports balancing acts with others. The social-emotional skills of turn-taking, cooperation and negotiation are built up when passing each

other on the tight rope, avoiding to have to step down.

## Horizontal rope

**Physical:** the stiff, bouncy rope is great for walking in arms or hanging in knees. **Social-**

**Emotional:** children cooperate, help each other and take turns.



## Balancing ropes

**Physical:** holding onto the swaying upper rope when balancing on the swaying lower rope makes excellent training of the sense of balance and trunk muscles. These abilities are fundamental for being able to sit still. **Social-Emotional:** there is room for more than one and cooperating with friends on walking over the swaying ropes is a true cooperation task that requires teamwork and tolerance.

All Organic Robinia products by KOMPAN are made of Robinia wood from sustainable European sources. On request it can be supplied as FSC® Certified (FSC® C004450).



Nets and ropes are made of UV-stabilised PA with inner steel cable reinforcement. The rope is induction treated in order to create a strong connection between steel and rope which leads to good wear resistance.



The Robinia wood can be supplied as untreated raw wood or painted with a brown coloured transparent pigment that maintains the golden wood colour of the wood.

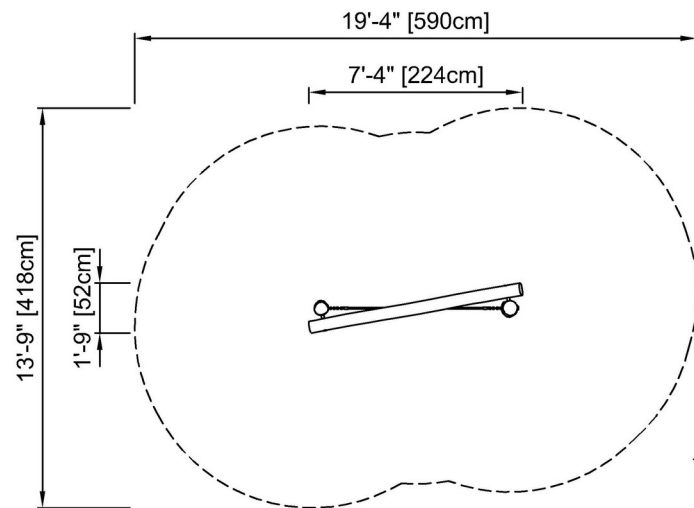

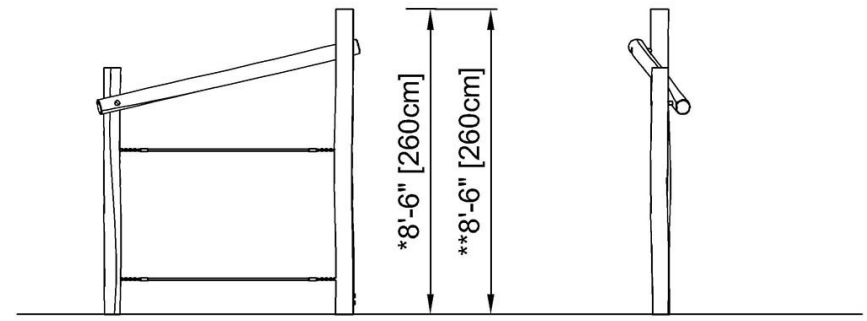
