
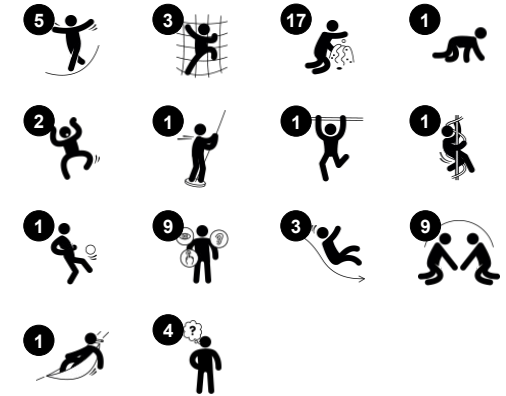

This fun, sturdy Triple Mega Deck will attract toddlers over and over. It invites to explore the various auditive and tactile play panels, stimulating logical thinking and creativity in the child. The drums create variation in sound and can be played alone or together, inviting for social interaction. The tunnel support climbing, crawling and cross-coordination. This

stimulates cross-modal perception, important e.g. for reading. The bubble window in the tunnel bridge distorts voices when spoken into, evoking a sense of wonder and training logical thinking. From the roomy platforms a curly climber invites for a thrilling rotating ride back to ground level. There is a double slide also, which allows for carers to join in. The house

platforms offer appealing tactile details to explore, training logical thinking. So this is fun play and training of life skills.

## Accessible stairway

**Physical:** climbing the accessible stairway is for all and supports cross coordination as well as arm and leg muscles. For young children, walking stairs and alternating feet is developed. **Social-Emotional:** room for active breaks and adult helpers. An inclusive space.



## Play sphere

**Social-Emotional:** can be played from both sides, encouraging cooperation. **Cognitive:** cause and effect understanding. **Creative:** leave a mark and place the spheres at different positions.



## Drums

**Social-Emotional:** cooperation and co-creation, parallel and group play. **Cognitive:** cause and effect understanding when creating sounds, supporting a sense of rhythm, that is essential for pre-reading skills. **Creative:** creating and leaving a mark with sound.



## Bubble Tunnel

**Physical:** the children crawl through the tunnel, developing motor skills such as cross-body coordination and proprioception. **Social-Emotional:** turn-taking when passing each other. **Cognitive:** distorts the sound of the voice, developing logical thinking.



## Curly climber

**Physical:** coordination and proprioception are supported when placing arms and legs correctly for going down. Sense of balance when rotating. Arm muscles for holding tight. **Social-Emotional:** empathy stimulated by turn-taking. **Cognitive:** logical thinking when placing arms and legs right for rotating downwards.



## Rock climber

**Physical:** supports cross coordination and leg, arm and hand strength. **Social-Emotional:** the inclination makes climbing feel secure, especially for younger children.



## Double slide

**Physical:** sliding develops spatial awareness and a sense of balance. Furthermore, the core muscles are trained when sitting upright going down. **Social-Emotional:** invites socializing, supports parent-child and peer-to-peer play. **Cognitive:** young children train their understanding of space, speed and distances when sliding down quickly.

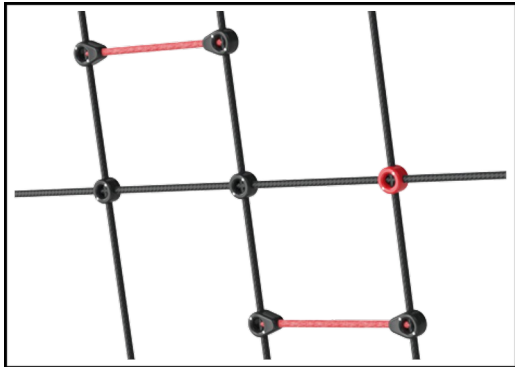
Panels of 19mm EcoCore™. EcoCore™ is a highly durable, eco friendly material, which is not only recyclable after use, but also consists of material produced from +95% recycled post consumer material from food packing waste.



Main posts with hot dip galvanized steel footing are available in different materials: Pressure impregnated pine wood posts. Pre-galvanized inside and outside with powder coated top finish steel posts. Lead free aluminum with color anodized top finish. Greenline TexMade posts of 95% post-consumer recycled PE and textile waste.



All decks are supported by unique designed low-carbon aluminum profiles with multiple attachment options. The grey colored molded decks are made of 75% post-consumer waste PP material with a non-skid pattern and texture surface.



Ropes of UV-stabilized PES rope strands with inner steel cable reinforcement. The polyester yarn is made from +95% post-consumer materials and is inductively melted onto each strand.



Wood version of FSC®-certified (FSC®C004450) pine wood with pressure impregnated base treatment and brown painted top finish. Vertical boards and top ends protected by a unique aluminum profile for high outdoor durability.



Shade sails of commercial 95 high density PE knitted specially for sunshade structures. The sails are treated with UV stabilizers to ensure a long lifetime. The sails are supported by a hot dip galvanized steel frame. Closed sail equipped with an easy take down system.

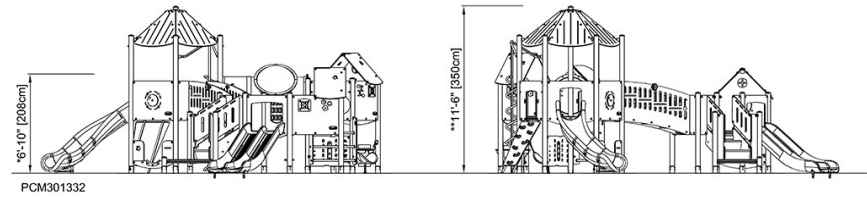
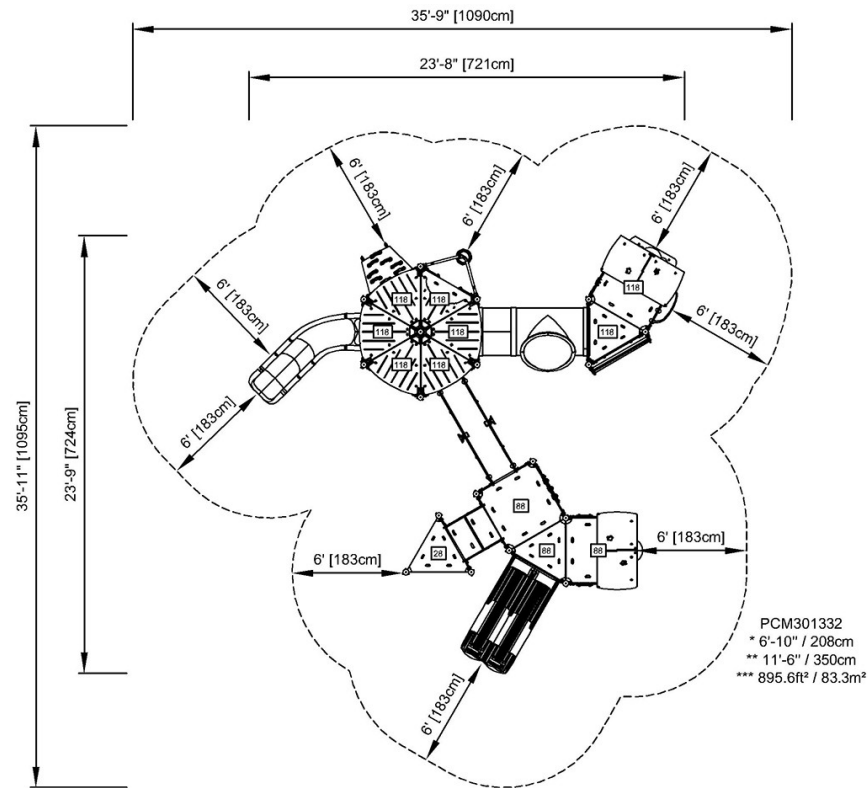
