Cross-coordination enhances children's ability to use both sides of the brain, supporting the internal structures enabling reading and thinking. The children also train cross-coordination when

climbing to the thrilling reward: a stomachtickling ride down the slide. Sliding stimulates balance, which is fundamental for mastering any physical activity. When deciding who to go next, children develop empathy and turn-taking skills. The tractor is a great facilitator for social, dramatic, and physical play.

#### Slide

Physical: sliding develops spatial awareness and a sense of balance. Furthermore, the core muscles are trained when sitting upright going down. Social-Emotional: empathy stimulated by turn-taking. Cognitive: young children develop their understanding of space, speed and distances when sliding down quickly.





#### Switch

Cognitive: an understanding of cause and effect is developed when pushing something that moves. The theme of light switch supports dramatic play, which is known to stimulate language skills.







Physical: the children crawl through the tunnel, developing motor skills such as crossbody coordination and proprioception. Social-Emotional: turn-taking when passing each other.







Social-Emotional: trains cooperation and turn-taking as children put materials into the funnel. Cognitive: the passing of materials through funnels supports the children's logical thinking and for younger children the understanding of object permanence: that materials don't vanish but run through at the other end.





Physical: handhold provides good grip for less confident climbers. Pulling yourself up and in trains upper body muscles.





Social-Emotional: cooperation, turn-taking, sharing. Cognitive: suggests a theme and supports dramatic play, which stimulates languages skills.









#### Turning wheel

Social-Emotional: develops turn-taking, communication and cooperation. Cognitive: the manipulative item stimulates cause and effect understanding, logical thinking and communication. Creative: working with moveable play items that can leave a mark supports the child's creativity.





