The steel surfaces are hot dip galvanised inside and outside with lead free zinc. The galvanisation has excellent corrosion resistance in outside environments and requires low maintenance.



The basketball hoop is made from hot dipped galvanized steel with a powder coated finish. The net is made from KOMPAN Ø5 PA Rope reinforced with steel wire. The net has a circumference of ~Ø30cm at the bottom and ~Ø50cm at the top.

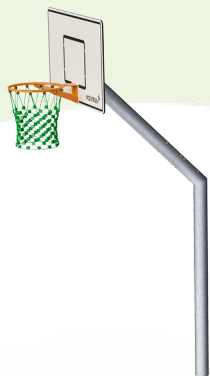

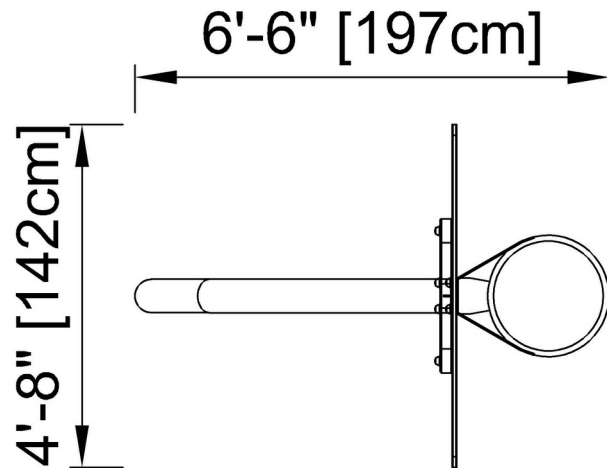

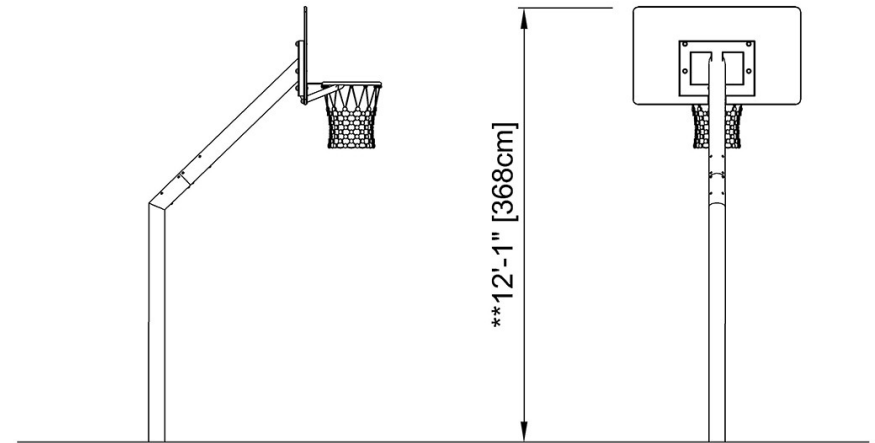
