Compact and complete street workout and callisthenics combination for training and competition. It features an incline bench, parallel bars, push up bar, decline press, Swedish ladder and pull up station. Seven workout stations in one, and all within only 41 m<sup>2</sup>. The 138cm wide pull up bars are designed to give plenty of space for dynamic exercises

and promote sideways exercises such as the typewriter pull up. The wide bars also allow for users to do pull ups next to each other and thereby compete or motivate each other.

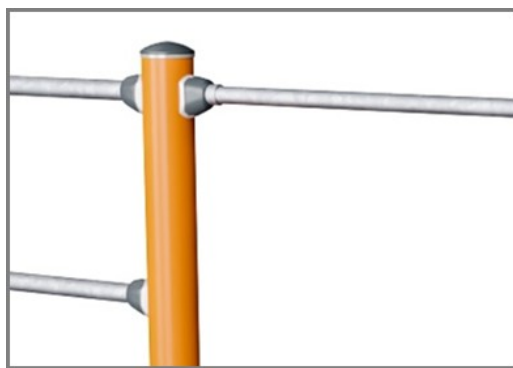

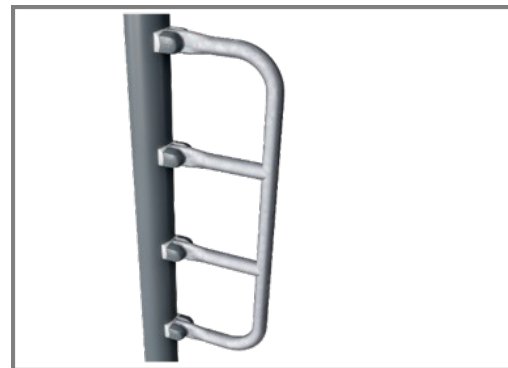

The connectors are made of die-cast aluminium, specially alloyed for the outdoor environments and heavy usage. The screws attaching the connectors are stainless steel and protected by zinc washers.



All bars intended for pull ups are made of solid,  $\varnothing 32\text{mm} \times 138\text{m}$ , hot-dip galvanised, S235JR steel bars. This diameter gives the right grip for all users.



The FSW 209 features three 38 x 2mm push up bars at three heights of respectively 38cm, 58cm and 133cm.



The post is made of  $\varnothing 101.6 \times 2\text{mm}$ , pre-galvanised carbon steel and powder coated which is a great protection solution for all climate conditions.



The surface is made of Ekogrip™ panels, consisting of 15mm polyethylene with a 3mm top-layer of thermoplastic rubber. The Ekogrip™ panels have a non-skid effect for comfortable and safe training at all weather circumstances.

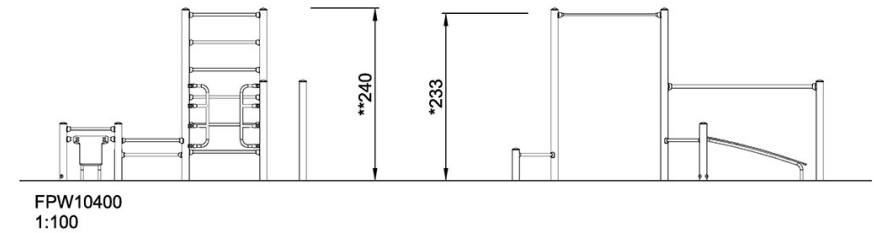
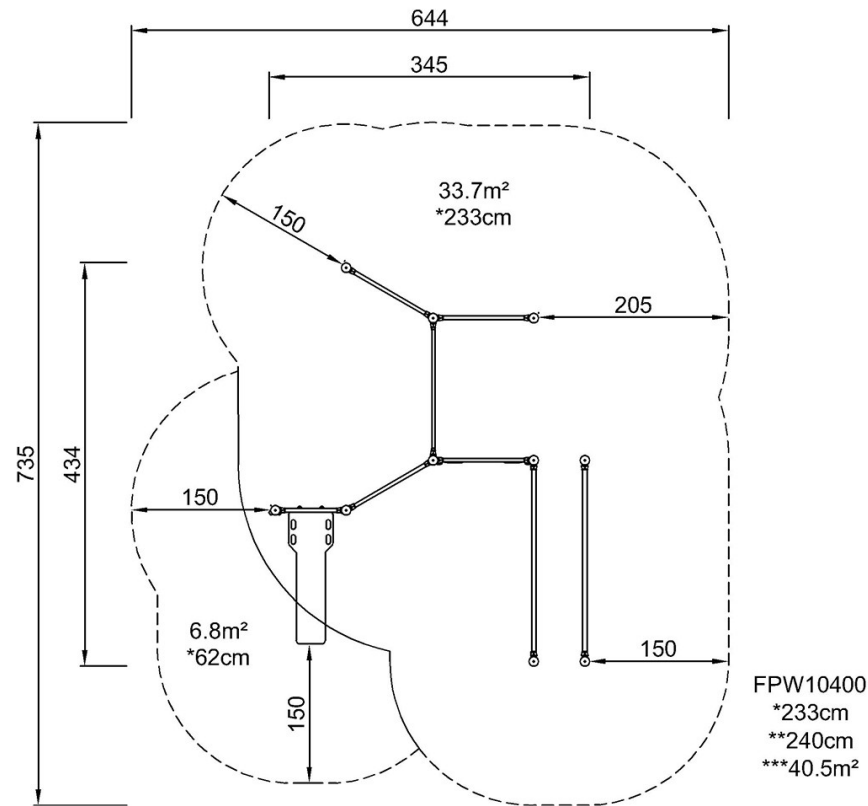
