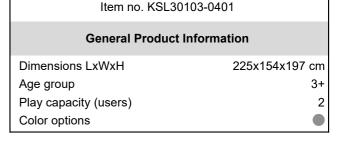

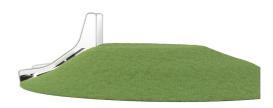

Wide slide

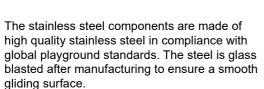

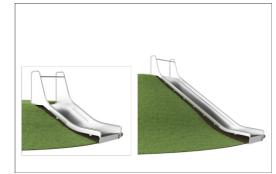








At 35°, the slide is set to the optimum angle to ensure both gliding fun and safety.

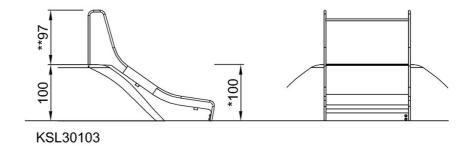
