


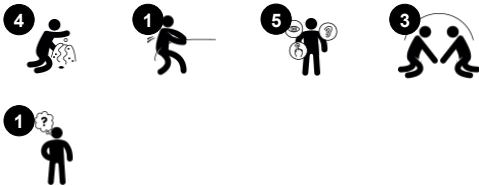

This allows for more children in action, in spite of the small foot-print. The Sand Des is the main attraction: the sieve and tube in each their way leads sand to the ground level. This is an

eternal source of wonder for young children. It develops their understanding of object permanence: that things don't necessarily cease to exist, when you cannot see them anymore. For cognitive development this is fundamental. The shovels can work horizontally or vertically, transporting material from side to side or up and down. This trains spatial

awareness as children communicate and negotiate their explorative play adventures, building social skills.

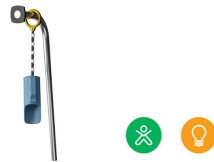
## Funnel

**Social-Emotional:** trains cooperation and turn-taking as children put materials into the funnel. **Cognitive:** the passing of materials through funnels supports the children's logical thinking and for younger children the understanding of object permanence: that materials don't vanish but run through at the other end.



## Sand desk with bowl and sieve

**Social-Emotional:** children can gather and store materials, cooperate and take a break together. **Creative:** sand can be shifted through the sieve, for understanding of cause and effect and object permanence.



## Sand shovel

**Physical:** develops dexterity and upper body muscles. **Cognitive:** understanding of object permanence, emptying and filling scoop.



## Lower platform

**Physical:** climbing up, jumping down develops muscle and motor skills such as coordination, which are important in navigating your body securely through the world. **Social-Emotional:** children can sit and talk together. The step helps children who need extra height to maneuver the tap and water channel.

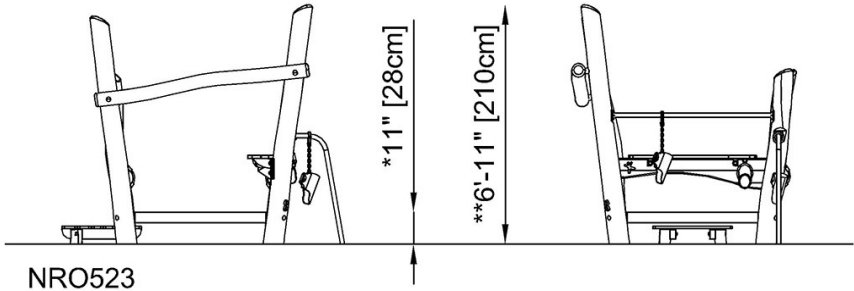
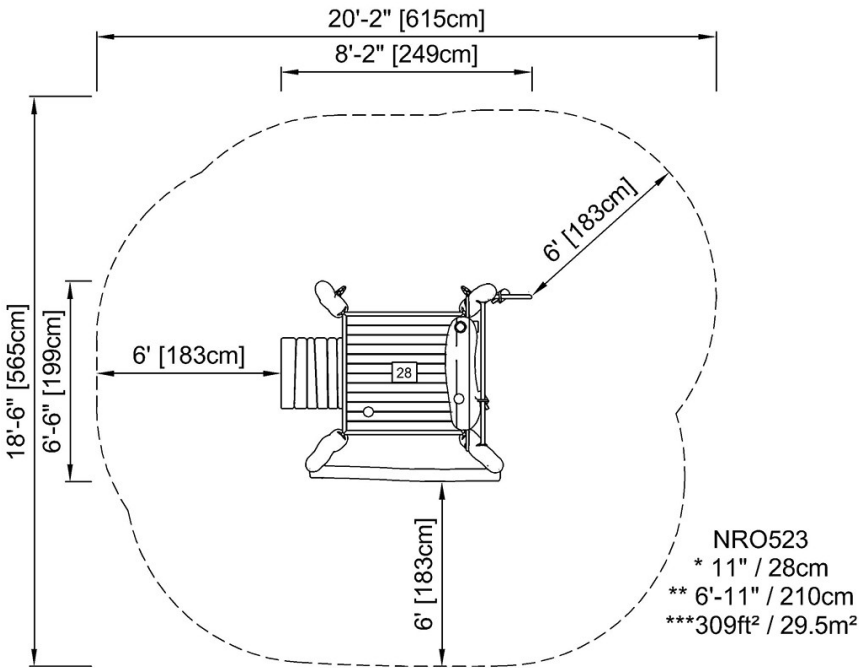
